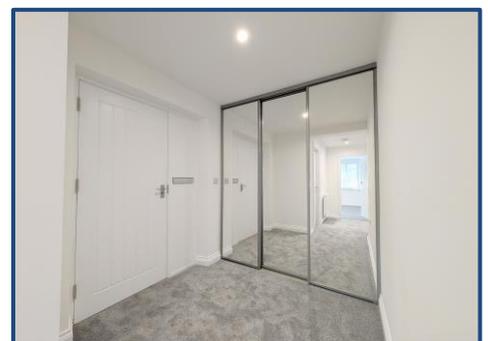
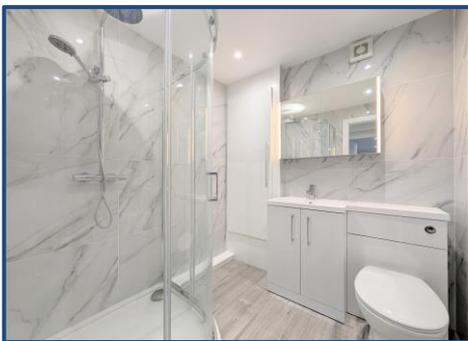

Bedroom One

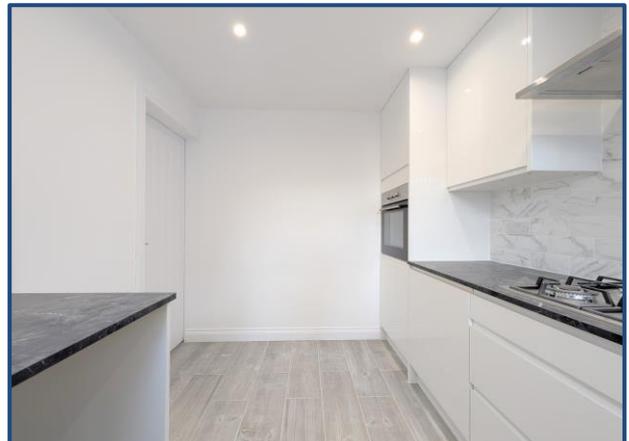

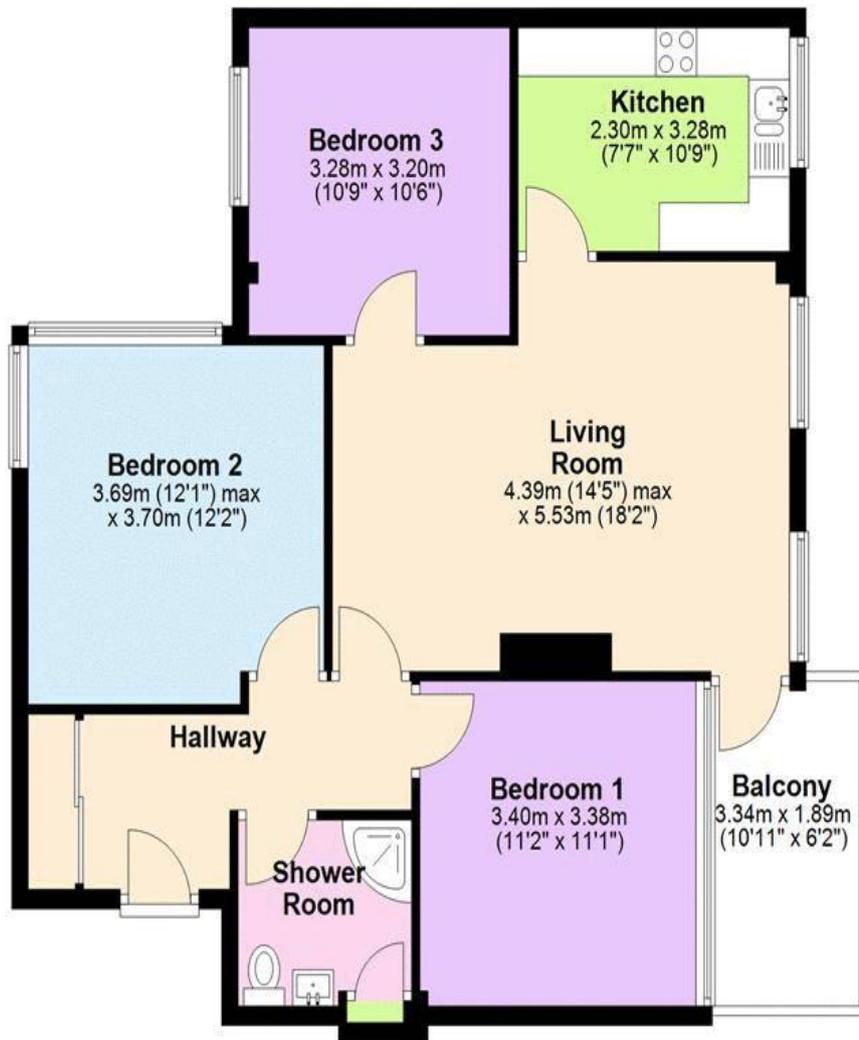
