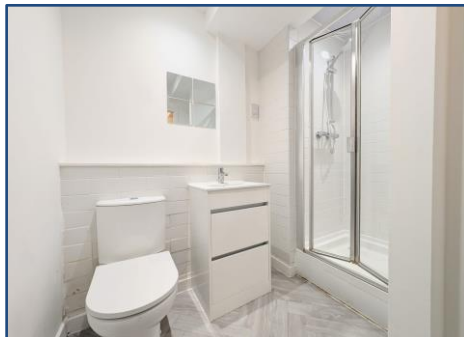

Rooms

Entrance Hallway 31' 3" x 3' 8" (9.53m x 1.12m)

The communal entrance provides access to this penthouse apartment which benefits from being the only apartment on this floor. There is an inviting entrance hallway with intercom system. There is a large double door storage cupboard to side and additional one to the far end.

Bedroom '1' 11' 5" x 11' 0" (3.48m x 3.35m)

Generous size, light and bright double bedroom with sliding doors presented to the front aspect providing access on to the balcony. Carpet laid underfoot.

Bedroom '2' 7' 7" x 6' 1" (2.32m x 1.86m)

Generous size, light and bright second double bedroom with sliding doors presented to the front aspect providing access on to the balcony. Carpet laid underfoot.

En Suite Bathroom 7' 8" x 5' 6" (2.33m x 1.67m)

En suite bathroom with fully tiled walls and floor. Suite is comprising of a paneled bath, low level dual flush WC and pedestal sink.

Lounge/Kitchen 20' 0" x 17' 4" (6.10m x 5.28m)

Open plan kitchen to the reception lounge with carpet laid underfoot in the reception lounge and tiled floor within the kitchen area. There are a good selection of high gloss base and eye level units fitted throughout with integrated appliances comprising of a four halogen hob, oven and grill, washing machine/dryer and a stainless steel sink and drainer. 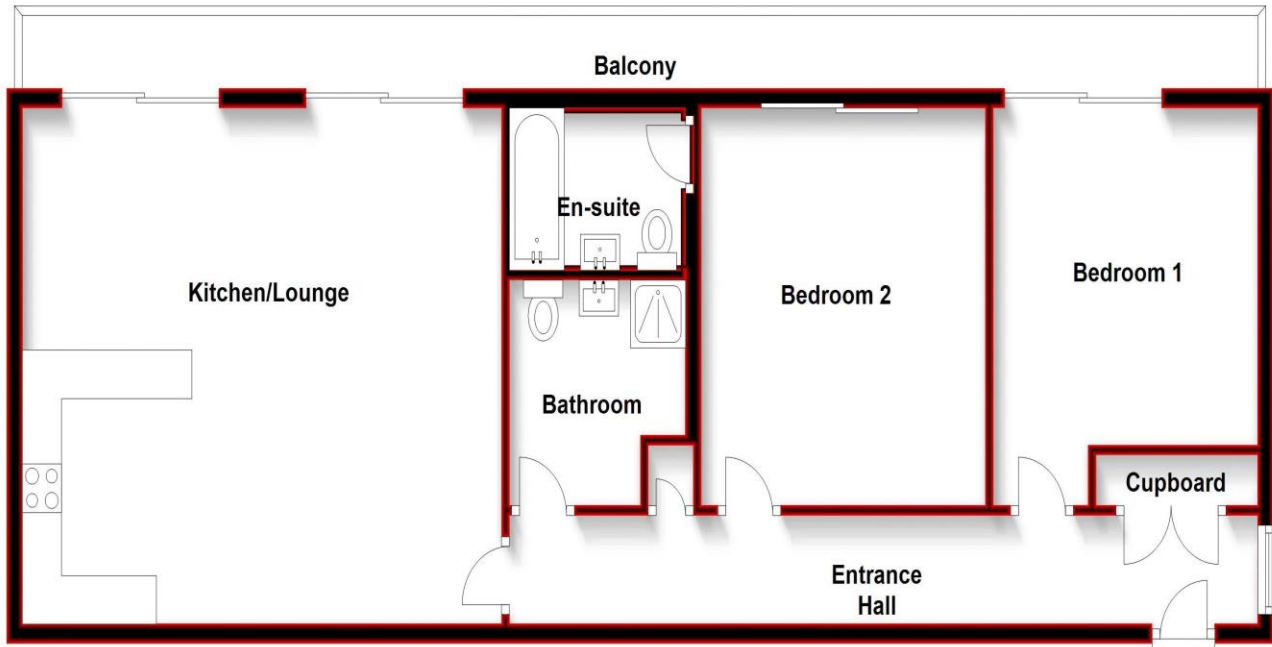
